1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue no. GPN 01 of July 16, 2008.
2. The People's Republic of Bangladesh has received a credit from the International Development Association toward the cost of Clean Air and Sustainable Environment Project, and it intends to apply part of the proceeds of this credit to payments under the Contract for Vehicular Emission Testing Equipment (Contract Package No. DOE-G04)
3. The Department of Environment now invites sealed bids from eligible and qualified bidders for Vehicular Emission Testing Equipment.
4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
5. Interested eligible bidders may obtain further information from Project Director, Clean Air and Sustainable Environment (CASE) Project, Department of Environment, E-Mail: nasiruddin @doe-bd.org and inspect the Bidding Documents at the address given below from office hours 9:00 -17:00 Hrs
6. Qualifications requirements include: The bidder shall have at least three (3) years experience of successfully supplying and installation of Vehicular Emission Testing Equipment. Bidder shall have to provide information as required in the Bidder's Statement of Qualifications. A margin of preference for certain goods manufactured domestically is applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non refundable fee BDT 2,000.00 or in convertible currency equivalent to US\$ 30.00. The method of payment will be either in cashier cheque or in certified cheque, or in payment order/ bank draft from any scheduled bank in Bangladesh. The Bidding Documents will be sent by Air Mail for overseas delivery and courier service for local delivery.

8. Bids must be delivered to the address below at or before 4.30 pm March 19, 2012. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 4.45 pm, March 19, 2012. All bids must be accompanied by a "Bid Security" of BDT 200,000.00 or an equivalent amount, in a freely convertible currency.
9. A Pre-bid conference with the representatives of prospective bidders will be held at the address below at 11:00 am on February 16, 2012.
